


**Jeanene M. Kress**, BAE '89, has been named one of "Eight over 80" for 2023 by Crain's Cleveland Business. The eight Northeast Ohioans, all 80 or older, have been recognized this year as they embody ikigai, which translates to "purpose in life", as they continue to live meaningfully to the benefit of our community. Kress has a slew of sage advice, something that has come not only from her 82 years – including the years raising five children and her most recent job as a trustee – but from a varied and constantly evolving career. Kress started out as a schoolteacher, then went on to run a small business with her husband for more than 30 years while also serving on the school board and working in the community as a "self-proclaimed activist." Kress found her way back to finishing her college degree in her 50s before running for public office. Kress has become a trusted adviser working with the Northeast Ohio Areawide Coordinating Agency (NOACA). And as an Olmsted Township trustee, she is



currently spearheading a nature trail and a park in the southwest part of the township that will include a 1-mile walking track and a 3-acre dog park.

**Keith B. Lay**, BM '84, MM '88, has been deemed by *New York Times*' head critic as "a composer to watch for," and *Gramophone* magazine has described his music as "unapologetically emotional." By age 18, Lay had completed works for wind ensemble, big band, choir, piano, and various small ensembles. While developing a career in commercial music, Lay eventually became a full-time producer using the Synclavier digital music system: the most advanced music technology of that era. Keith is currently working on what he calls "Distance Music:" an outdoor concert form of location-based minimalism exploiting the natural time delays between radiocontrolled train horns and musician groups — each geometrically located over tens of acres. His movement, *Children on the Playground*, was composed in 2000 for his friend, Alex Dean, who premiered it with the United States Air Force String Orchestra on August 28, 2002. That year, it won the Riverside International Composition Contest for reading in New York City. A few years later, it was chosen from a select pool of 20 winning entries from a field of 500 submissions over 11 years to win the Riverside Grand Prize.



**James G. "Jim" Maser**, BS '83, MS '85, Senior Vice President of Aerojet Rocketdyne's Space Business Unit, was selected as a 2023 Honorary Fellow of the American Institute of Aeronautics and Astronautics (AIAA) and elected as a member of the National Academy of Engineering (NAE). An AIAA Honorary Fellow is the top honor bestowed by AIAA that recognizes recipients for their eminence in aeronautics or astronautics and is only given to less than 1% of its membership. Being elected as a member of NAE is also one of the highest professional honors accorded in the engineering profession. NAE members have distinguished themselves in business and academic management, in technical positions, as university faculty, and as leaders in government and private engineering organizations. Maser has enjoyed a distinguished aerospace career,



spanning entrepreneurial space launch, human spaceflight, as well as commercial and military jet engines. In his current position, he is responsible for critical propulsion programs supporting the nation's defense and exploration endeavors, including the 53 elements on NASA's Space Launch System and Orion spacecraft that were built by Aerojet Rocketdyne, and performed spectacularly during the Artemis I mission.
