STANDARDS OF SATISFACTORY ACADEMIC PROGRESS POLICY FOR FEDERAL TITLE IV STUDENT FINANCIAL AID RECIPIENTS

REQUIREMENTS FOR GRADUATE & LAW STUDENTS

These rules and regulations are subject to change

Federal Regulations require that The University of Akron review the academic progress of students applying for and/or receiving federal Title IV student financial aid. This rule applies to all students applying for aid, whether or not financial aid has been received previously. Students' progress will be checked prior to the initial receipt of financial aid and at the end of each semester. If it is determined that you are not making satisfactory academic progress toward your degree, you will no longer be eligible to receive federal Title IV student financial aid based on the policies and procedures that follow. There are both a quantitative (maximum time frame/completion rate) and a qualitative (grade point average) measure in determining satisfactory academic progress for federal Title IV student financial aid programs.

MINIMUM HOURS TO BE COMPLETED	Students must <u>successfully complete</u> a minimum of 70% (rounded down) of the total number of hours for which they are enrolled on the 15 th day of the semester/term. All courses for which you are registered on that day are counted as an attempted course whether you withdraw from, receive a failing grade for, or otherwise fail to complete the course. To determine the number of credit hours you are required to successfully complete during the semester/term (or cumulatively) to remain in compliance, multiply the number of hours for which you are/have enrolled on the 15 th day by 0.70. Example:

	PLEASE NOTE: Successful completion of a course, for the purpose of the Satisfactory Academic Progress calculation is determined by the passing grades as indicated by your college and/or program.					
	Incompletes (I) grades are counted as unsuccessful attempts. Once an incomplete grade has been changed to an A, B, C, or CR, it can be added to the number of hours completed for the term of the original registration. It is the student's responsibility to notify the Office of Student Financial Aid once an Incomplete has been changed to a validht! As A A A A A A A A A A A A A A A A A A					
GRADE POINT AVERAGE	Your grade point average must be equal to, or higher than, the standard established by your academic department. A minimum 2.3 accumulative GPA (effective with spring 2016 admits) and 2.0 accumulative GPA (prior to Spring 2016) Law School ; and a minimum 3.0 is required for the Graduate School .					
HOURS ATTEMPTED MAXIMUM TIME FRAME	LENGTH OF TIME IN SCHOOL THAT A STUDENT CAN RECEIVE FEDERAL AID:					
	Students are required to complete their degree requirements within a specified time frame. Federal regulations require that students complete their degree program by the time they have attempted 150% of the hours normally required for completion of the degree. For example, a program that requires a total of 60 credit hours must be completed by the time students have attempted 90 credit hours (60 x 150%).					
	For transfer students, academic progress will be reviewed to determine the status of each student in relationship to his/her program's maximum time frame. Once transfer credits are posted, they will be considered in our next satisfactory academic progress review. Transfer hours will be included in the cumulative number of hours earned and attempted.					
	The 150% maximum time frame allowance for completion of the program is intended to be long enough to allow for changes in major, loss of credit due to transfer, withdrawn coursework, minors, double majors, etc.; therefore, no extensions of the maximum time frame will be granted for those reasons.					

IF YOU DO NOT MEET THE STANDARDS OF SATISFACTORY PROGRESS

Students who fail to meet the Standards of Satisfactory Academic Progress will lose eligibility for the Federal Title IV student financial aid programs. They will be notified, in writing, of this action. In addition, they will be provided the opportunity to appeal this decision based on mitigating circumstances that may have occurred during the year or semester that could not have been anticipated (see below).

APPEAL PROCESS

Students who have lost eligibility for federal Title IV student financial aid may appeal that decision by following the procedures outlined below. Those wishing to utilize this process must be able to document mitigating circumstances that occurred during the course of the semester(s) in question that could not have been anticipated prior to that semester(s), and that adversely affected their ability to successfully complete their required coursework. Events such as the death of an immediate family member, extended illness suffered by the student, or other unforeseeable events that may have caused significant hardship for the student may be considered as examples of mitigating circumstances.

REGAINING FULL ELIGIBILITY

Students who have been placed in **Financial Aid Probation** or **Ineligible** status may regain <u>full eligibility</u> for federal Title IV student financial aid by successfully completing coursework while in that status that will raise their Grade Point Average to meet or exceed the minimum requirement based on their total number of hours attempted, and / or raise their coursework attempted to the 70% (rounded down) level.

Students who are **Ineligible** to receive federal Title IV student financial aid may use one or more of the following payment options while attempting to regain eligibility for federal Title IV student financial aid:

- 1. Student's own resources
- University of Akron Installment Payment Plan (IPP)
 Private Alternative Educational Loan Programs, alth
- 3. Private Alternative Educational Loan Programs, although some private lenders require the student to meet Standards of Satisfactory Academic Progress policy requirements.

Students who have taken the necessary measures to regain eligibility for federal Title IV student financial aid programs should contact the Office of Student Financial Aid immediately upon doing so and apply for Reinstatement of Eligibility. Students' academic performance will then be reviewed and, if all required Satisfactory Academic Progress criteria are met, full eligibility for federal Title IV student financial aid will be reinstated, effective the following semester.
