- UC Committee Updates
 - o IT Committee
 - Steve Sedlock: Budget and Finance meeting 09/03/2013
- Enrollment Status Diane Raybuck
 - 7% shortfall currently for Fall enrollment
 - Discussion about Cuts/Reductions in each member's business unit
 - Dan Satter no people just not filling open positions; reduced marketing spending
 - Mike S VPs and Deans meeting to reduce costs; 10% reduce/find efficiencies/opportunities for revenue; Team had a brainstorming session to find ways to reduce costs
 - Herb IT asked to share ideas in May which might be sent forward; example of cell phones on campus we are one of only 2 HE institutions (YSU is the other) which provide cell phones; average cost is \$100/phone for 120-130 phones monthly; eliminate this and save ~ \$250K
 - Denise M our division spends \$1,200 \$1,300 monthly on cell phones

- Carol Enrollment at Wayne is down but applications are up; sharing personnel with UA and Medina; froze tuition with no impact
- Steve S According to David Cummins, attrition is not going to correct the shortfall problem
- Team discussion about Retire/Rehires and questioned the rationale for their continued employment and their salaries; if critical, cap the salary at what a replacement would cost
- Team Discussion about why there are no community forums or meetings to discussion state of affairs
 - Steve S email he has from Dr. Proenza states that these meetings are coming
 - Budget & Finance Meeting returned to the subject of furloughs for further investigation
 - A list of individuals has been presented to Dr. Proenza from David Cummins to create a committee to do an 8% reduction across the board which would result in ~ \$16M savings
- Denise M Why have we grown from 3 VPs to 12 VPs...what is that rationale and where are the massive improvements from additional leadership?
- o Carol Where is the Efficiencies and Effectiveness Committee Report?
 - 342 students were turned away from UA and none went to Wayne why? Hundreds of these students are in Lakewood area & Cuyahoga County no transportation options to get to Wayne Campus
 - Diane R No residence calls at branch campuses; need to coordinate with local housing options for UA students
 - Wayne faculty teaching at UA were informed that the UA Faculty Union would not allow it
- Diane R Dissatisfied...why? 2,300 students were eligible to return to UA for Fall semester – phone blast conducted. 687 from Akron area and 900 more within a 40 minute commute to main campus; All in Academic and Financial good standing
 - No cuts; need more students/higher enrollment
 - Retention is HUGE issue and MAIN focus

 - State of CPs on Campus what to discuss?
 - What do we do as CPs? / Budget Suggestions / Morale realistic administration expectations
 - When? Week of September 23rd
 - Format? Boxed Lunches; RSVPs
