 - Debt reduction strategies, 32 million a year in debt service (interest on debt) leads to using reserves in past, parking led to diffusing some of the debt, in 4 years will start to naturally drop off, this year will be 10 million, hoping to close deal on residence life & housing, deficit in operating budget even after the debt service, managed with strategic, provost will be working with deans & groups to understand the budget, don't foresee any big changes with staffing, focusing on revenue generation, cost shared
 - Dallas did excellent job of implementing the parking deal,
